

CCAF International Legislative Oversight Program: CAMEROON

The CCAF partnership with le Contrôle Supérieure de l'État (CONSUPE)

Performance audit and legislative oversight are at early stages in Cameroon. Prior to the ILOP, the CONSUPE (Cameroon's supreme audit institution, or SAI) had conducted one performance audit. It was directed by CCAF graduate Fellow Pauline Kane Fortune and was a pilot for the SAI and for the region. Ms. Kane Fortune now holds a senior position at the office, and the CONSUPE is currently conducting performance and environmental audits that have been initiated through the ILOP. This includes audits conducted through the AFROSAI-E 3-module training program; although Cameroon is not an AFROSAI-E member, CCAF has been able to engage the CONSUPE in three deliveries of this training.

The CONSUPE has identified particular needs in the following areas: significantly improving quality control and assurance; building applied knowledge and experience in performance auditing; developing environmental audit knowledge and experience; improving the management and measurement of its own performance; and developing and deploying a strategy for communicating and building relationships with external stakeholders, including Parliament and its Commission des Finances.

There is no legislative oversight committee receiving the SAI's audit reports; the SAI reports directly to the President in accordance with legislation and with the presidential system in place, similar to other Francophone and Portuguese African countries.

Background on CCAF and the International Legislative Oversight Program

CCAF-FCVI Inc. (formerly called the Canadian Comprehensive Auditing Foundation) is a non-profit research and educational organization that promotes effective performance audit and oversight of government operations. CCAF's International Legislative Oversight Program aims to contribute to improved transparency, effectiveness and accountability in public resource management in four countries: Cameroon, Ghana, Tanzania and Vietnam. The program runs from 2012 to 2017. It builds upon the success of our previous five-year program (the International Legislative Audit Assistance Program, 2007-2012) and CCAF's history of international engagement, which dates to 1980.

The program's principal activities are Fellowships (for senior auditors) and internships (for SAI managers) in Canada; in-country and regional workshops; online distance education courses; support for SAI management on matters such as performance measurement and strategic planning; and ongoing mentoring and follow-up. Participants in the nine-month Fellowships are required to develop performance audit plans that they will conduct when they return from Canada. Participants in the 3-module training program delivered with AFROSAI-E are required to plan, conduct and report performance audits. Activities are delivered with our many Canadian partners—federal, provincial and municipal audit offices that share their expertise by volunteering to be Fellowship hosts, training co-facilitators, and mentors.
